











Campus Map TU Delft






Walking routes between the three different buildings



Building X (number 27) to Building 31 (number 31) 15 minutes walk







Building X (number 27) to Building Aula (number 20) 12 minutes walk




Maps of rooms in building X













Maps of indoor facilities building X **Ground floor** Up to Rhythm and Aerobics main entrance Up to all other Forecourt Campus North > (East Square)






Second floor
